"Companies must embrace the everdeveloping sustainability and ESG environment for business success in 2023. - 1. Circular economy model: Consumers and producers alike increasingly seek to extend the product lifecycle via the circular economy model. Innovating the product design process and paying attention to the end-of-life disposal implications are worthy considerations. For IT systems, keeping track of and minimizing e-waste is crucial.




CAPITRON BANK, CU, AND CREDIT **GUARANTEE FUND TO GRANT LOANS TO WOMEN ENTREPRENEURS**

Capitron Bank, a supporter of sustainable development, has signed a cooperation agreement for franchising loan products for women entrepreneurs to support projects and business activities that are important for environmental and social development. Specifically, in order to meet the financial needs of women entrepreneurs and support them in doing business, Capitron Bank Executive Director B. Urtsaihbaatar, Central Express JSC Executive Director G. Chinzorig, and Credit Guarantee Fund Acting Executive Director S. Tsogtsaihan saw the above agreement. With the signing of this agreement, Capitron Bank will provide loans to women entrepreneurs who are eligible for CU franchise loans and will be guaranteed by the Loan Guarantee Fund. In this way, it is important to provide flexible, favorable terms, lowinterest loans to women entrepreneurs, to increase the participation of women in the business sector, to create their leadership, to contribute to the improvement of living standards, and to support sustainable business operations.











Rio Tinto Mongolia is combating forest defoliators to save Mongolian Forest. Rio Tinto will contribute MNT 7.4 billion to support the project, overseen by the Ministry of Environment and Tourism (MET) of Mongolia and implemented by the International Conservation Caucus Foundation (ICCF). Over 2 years, the project aims to treat 300,000 hectares of impacted areas through aerial spraying, reducing the number of forest defoliators.

The Healthy Forest Project, is the first major component of the Memorandum of Understanding on Cooperation to Combat Climate Change and Desertification signed between the MET and Rio Tinto Mongolia.

Mongolia's forest-covered area currently comprises 7.9% of its territory. Recent research conducted by MET revealed severe outbreaks of defoliators in 2022 due to climate change and Covid-19 restrictions. Without immediate action, up to 700,000 hectares of forest area will suffer severe degradation.

With the help of ICCF experts, the project will introduce international techniques to increase treatment efficacy by 90%, develop university programs for training specialists, and share best practices in sustainable forest management. These measures aim to protect Mongolia's forests and ensure their conservation for future generations.

STATE BANK CALLS FOR **INHERITANCE FOR A GREEN FUTURE**



Since 2018, employees of State Bank have been running the 'Gyals Eco-Clean up' campaign to call for organizations and the public to protect the environment and reduce their negative impact on the environment, urging them to love the Earth and inherit a green future for the next generation. In recent years, environmental degradation such as global warming, greenhouse gases and desertification have become an issue of considerable concern not only internationally but also for our country. Eighty percent of Mongolia's territory is affected by desertification. According to a study, 51 percent is caused by natural and climatic changes and 49 percent by human factors.

State Bank, which has branches throughout Mongolia, with the participation of its 4,000 employees from 500 branches, has cleaned up rivers, lakes, ponds and basins located in 21 provinces, 335 soums of Mongolia and nine districts of Ulaanbaatar city as part of the "Gyals Eco-Clean up" campaign implemented since 2018. During

the national clean-up weekend, 27,580 hectares of land, including the Tuul and Selbe river basins, were cleaned and more than 3,600 tonnes or approximately 2,000 lorry loads of rubbish were removed in the provinces and the capital city.

In 2022, the Tuul River Basin Authority under the Ministry of Environment and Tourism awarded the State Bank a certificate of appreciation for its valuable contribution to protecting the Khatan Tuul River, which is a source of drinking water for residents of the capital, and its clean up the Khatan Tuul River Basin with the full involvement by leading government and non-governmental organization.
